

- 3. That Air Force School Gurgaon is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
- 4. That no part of income from the Institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any after meeting the recurring and non recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5. That Air Force School Gurgaon is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organisation or body.
- 6. That Air Force School Gurgaon will not open classes under CBSE patter particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, direction issued from time to time and the law of the land.
- 8. That Air Force School Gurgaon will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
- 9. That Air Force School Gurgaon will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
- 10. That Air Force School Gurgaon will ensure that all required infrastructure is available with the school before starting classes.
- 11. That Air Force School Gurgaon will ensure that sufficient number of qualified teachers as per-the provisions contained in affiliation bye-laws are available with the school before starting classes.

- 16. That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the affiliation conditions contained in affiliation byelaws along with general rules.
- 17. That Air Force School Gurgaon will not sponsor from the other board.
